#### Who is eligible to register to vote?

Those who will be aged 18 or over on 15 February 2026 can register to vote if they are:

- Occupying as owner or tenant the whole or part of a property which is in that ward of the City.
- Personally and physically occupying those premises, on 1 September 2024, for the purpose of carrying out a trade, business, profession or other occupation or calling.

#### Electors must also be either:

- A British, Irish or Commonwealth citizen; or
- A European Union (EU) citizen of Denmark, Luxembourg, Poland, Portugal, or Spain who has permission to enter or stay in the UK, Channel Islands or Isle of Man, or who does not need permission\*; or
- A European Union (EU) citizen of any other EU country who on or before 31 December 2020 had permission to enter or stay in the UK, Channel Islands or Isle of Man, or who did not need permission, and this has continued without a break\*

\*Please note: EU citizens, who are not also Commonwealth or Irish citizens, may only vote in elections of Common Councillors but not Aldermen.

#### Ward Lists

The Ward Lists include everyone who is entitled to vote in City Ward elections. Your name must appear on the Ward Lists if you wish to vote in these elections. Provisional ward lists will be published from 30 November to 16 December 2024 during which period claims and objections may be made. The final lists will be in force from 16 February 2025 and used until 15 February 2026. You can check the Ward List by visiting the Town Clerk's Department at the Guildhall. # **REGISTER YOUR VOTE**

City workers can vote in the upcoming **City of London elections,** but must register by **30th November 2024.** 

The City of London is unique. **City workers, not just residents, can vote in our elections in addition to voting at home.** This makes sure workers' priorities get heard loud and clear, and helps the Square Mile remain one of the best places to work in the world.

Voters elect members of the City of London Corporation, which runs the Square Mile. Not only do we look after local services such as roads, rubbish collection, planning and the police - we also support and promote City businesses in the UK and internationally.

In March 2025, City voters will have the opportunity to elect 100 new Common Councillors to represent their interests. Don't miss this chance to have your say.

## 1. Who can register?

Sole traders and partners can register to vote if they were physically working at a City of London premises on 1st September 2024 and they owned or rented all or part of those premises. This includes all barristers in a chambers.

To qualify to register, City workers must:

- Have worked at your premises since 1 September 2023
- Be a UK, Irish, EU\* or Commonwealth citizen (See new requirements for EU voters)
- Be over 18 or will turn 18 before February 2026

# 2. Submitting your registration

You can either complete the form and return it in the envelope provided or follow the instructions to respond online. If your organisation registered voters last year these will appear on your form and online to simply edit and confirm. If not, you will need to give the details of each voter in full.

You should include voters' email addresses where possible. These are used to help provide important election information. Email addresses are not shared beyond the Electoral Services team.
